## Hygiene Control System Certification

By introducing the ISO 9001 concept with the implementation of Good Hygiene Practice, ACI has developed the Hygiene Control System Certification Scheme ("ACI-HCS") in order to develop a framework for managing health risks associated with public hygiene in a systematic manner.

Basic framework of ACI-HCS consists of Management Responsibility, Sanitary Facilities, Building Hygiene, Public toilets, Ventilation/Drainage/Garbage collection, Pest Control, Personal Hygiene and Hygiene Management System. Furthermore, samples of air, water and food must be subject to testing carried out by HOKLAS (Hong Kong Laboratory Accreditation Scheme) accredited laboratories for granting certificate.

ACI-HCS Certification encourages and serves industry sectors such as shopping arcades, restaurants, hotels, clubhouse and school, etc. to fulfil their commitment to public hygiene as pledged. Moreover, we may provide particular training courses in order to make the organisation understand more about system requirement.
